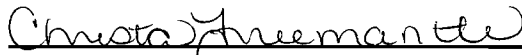

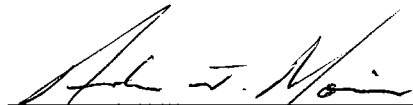
ADJOURNMENT:
