CITIZEN COMMUNICATION: The Historic District Commission welcomes and encourages participation in City Historic District Commission meetings, and will allow up to five minutes for expression on a non-agenda item. Matters under the jurisdiction of the Commission, and not on the posted agenda, may be addressed by the general public; however, California law prohibits the Commission from taking action on any matter which is not on the posted agenda unless it is determined to be an emergency by the Commission.

NEW BUSINESS:

1. **PN11-167, Bates Garage Addition, Historic District Design Review, 711 Mormon Street**

A Public Hearing to consider a request from BNB Construction for Design Review approval for the construction of a 720-square-foot detached garage located at 711 Mormon Street. The project site is zoned R-4 (General Apartment District) and the General Plan land-use designation for the site is MLD (Multi-Family Low Density). The project is categorically exempt from the environmental review requirements pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act (CEQA). The Historic District Commission will take final action on the project unless appealed to the City Council (**Project Planner, Kei Zushi, Associate Planner / Applicant: Brad Booker, BNB Construction, PO Box 5573, Auburn, CA 95603**)

2. **PN11-179, Garage Addition, Historic District Design Review, 606 Reading Street**

A Public Hearing to consider a request from Jon Hunter for Historic District Commission Design Review approval for a 260-square-foot addition to a detached garage at 606 Reading Street. The Historic District Commission will take final action on the project unless appealed to the City Council. The project site is zoned R-1-M, Single Family, Residential Small Lot District (Central Subarea of the Historic District) and the General Plan land use designation is SF (Single Family). This project is categorically exempt from environmental review pursuant to Section 15301 of the CEQA Guidelines (Existing Facilities). 3. **PN11-046, Sign Design Review, 511 Sibley Street**

A Public Hearing to consider a request from Auclair Consulting for Historic District Commission Design Review approval for a 6-square-foot freestanding sign at 511 Sibley Street. The project site is zoned R-1-M, Single Family, Residential Small Lot District (Central Subarea of the Historic District) and the General Plan land use designation is SF (Single Family). The project is categorically exempt from environmental review pursuant to Section 15311 (Accessory Structures) of the CEQA Guidelines. Any appeal of a Historic District Commission action must be filed, in writing with the City Clerk's Office no later than ten (10) days from the date of the action pursuant to Resolution No. 8081.
