Mayor Starsky pulled this item to express his concern that film companies be given the ability, but not be required, to use city services; he expressed further concern that the fees not evolve into mandatory service obligations placed on the film companies. City Attorney Cline advised that the proposed resolution articulates fees to be charged if city services are provided. Council Member Howell commented that city services are expensive and have been required for certain events in the past.

# **PUBLIC HEARING:**

Resolution No. 8624 - A Resolution Establishing Speed Limits on Glenn Drive, Sibley Street, 8a. Blue Ravine Road, Leidesdorff Street, Riley Street, Orchard Drive, Wales Drive, Duchow Way, Levy Road, Folsom Boulevard, Coolidge Drive, Coloma Street, Sutter Street, East Bidwell Street and Natoma Street (resolution amended)

Senior Traffic Engineer Rackovan made a presentation and responded to questions from the City Council.

Mayor Starsky opened the Public Hearing at 7:05 p.m. The following speakers addressed the City Council:

- Matthew Rozek inquired if the speed limits applied just to vehicles driving down Glenn Drive or to those trying to leave their homes in the California Hills subdivisions. Mr. Rozek guestioned the data sampling method. Council Member Sheldon commented about how the speed limit was set previously for Glenn Drive.
- Mark Clifford expressed opposition to increasing the speed limit on Glenn Drive.
- Lisa Davies commented about the speed survey methodology, and asked that this item be continued until a sight distance survey is conducted.
- Eric Costa expressed opposition to increasing the speed limit on Glenn Drive.

Senior Traffic Engineer Rackovan provided additional information in response to speakers' comments and questions. Public Works Director Lorenz provided additional information.

The City Council directed staff to examine possibilities to stripe a center turn lane on Glenn Drive.

• Robert Holderness addressed the City Council about land use in the area of Glenn Drive, suggesting that a change in land use might alleviate the traffic problems.

Hearing no further speakers, the Public Hearing was closed at 7:38 p.m.

Public Works Director Lorenz provided additional information, and suggested that a new speed survey be conducted.

Motion by Mayor Starsky, second by Council Member Howell to approve Resolution No. 8624, with the removal of new speed limits on Glenn Drive; that staff explore alternatives for Glenn Drive to be center turn-lane striped and re-speed surveyed. Motion carried with the following roll call vote:
