**NEW BUSINESS:**

1. **PN12-145, 381 and 391 South Lexington Drive, Tentative Parcel Map**

A Public Hearing to consider a request from the Davin Management Group for approval of a Tentative Parcel Map to divide an existing 1.87-acre parcel into two individual parcels. The zoning is BP PD and the General Plan is CA. The project is categorically exempt from the California Environmental Quality Act (CEQA) under Minor Land Divisions (15315). The Planning Commission will take final action on this project unless appealed to the City Council. **(Project Planner: Steve Banks, Senior Planner / Applicant: Davin Management Group, PO Box 998, Roseville, CA 95678)**

2. **PN12-135, Carefree Broadstone Senior Apartments, Planned Development Permit Extension**

A Public Hearing to consider a request from Jawa Studio, on behalf of the Templeton Development Corporation, for approval of a Planned Development Permit Extension (three-year) for development of a 348-unit senior apartment community at 1550 Broadstone Parkway. The zoning classification for the site is SP 95-1 and the General Plan land-use designation is MHD. A Mitigated Negative Declaration has been approved for the project (PN 04-139) in accordance with the California Environmental Quality Act.
